1. Call to Order

A. Dale called the meeting to order at 1:03pm.

2. Roll Call and Certification of Quorum – 17 Members Constitute a Quorum (2/3 of Members plus Chair)

The Recording Secretary called the roll and certified a quorum with 20 members present.

3. Chair's Remarks

A. Dale shared with the committee that W. Wright-Cascaden's recovery is progressing well. W. Wright-Cascaden participated in a source protection committee chairs teleconference on January 21, 2019 with Rod Phillips, Minister of the Environment, Conservation and Parks. The Minister is aware that a lot of valued work has been done as part of source protection program and that public awareness is good. The chairs emphasized the importance of source protection plans and presented a business case to the Minister providing benefits of the program. The chairs also urged funding to protect

the core-based program and expressed concern that the program does not cover all vulnerable populations, e.g., schools and northern communities. The Minister was sympathetic to the issues brought forward and the chairs offered to provide further information to the Minister.

9. Correspondence LATE STARTER

9.1 RE: Source Water Protection Committee Meeting and the Jet Fuel Spill into Mill Creek

Correspondence from Laura Murr to Ilona Feldmann, Source Protection Program Assistant, Lake Erie Source Protection Region.

M. Keller reported that the correspondence was an email received on Wednesday February 6, 2019. M. Keller responded to Ms. Murr that Lake Erie Region staff would bring a report to the committee in the near future with a more fulsome response to her concerns.

The jet fuel spill occurred along Highway 401 and made its way into Mill Creek. The Region of Waterloo was notified of the spill and shut down their GUDI wells immediately.

Lake Erie Region staff will bring a follow-up report to the committee once there is a more complete picture of the event, and will at that point discuss if there is something to be done from a committee perspective.

C. Hill asked where the spill occurred. S. Cooke provided a map of the spill location and Mill Creek and commented that the ministry focussed clean-up efforts at the point of the spill; however, some of the fuel moved into Mill Creek and downstream into the GRCA's reservoir. The ministry does not think it reached the Grand River. S. Cooke reviewed actions taken by the ministry once a spill occurs.

E. Hodgins commented the Region of Waterloo's Cambridge wells were shut off (2 wells) following the spill. J. Sepulis shared that Puslinch.ca has periodic updates on the matter and asked M. Keller if the committee should see Lake Erie Region's email response to Ms. Murr. M. Keller replied that the email response did not provide anything further than informing Ms. Murr that her email was included in the SPC agenda as a correspondence item and that a report will be brought back to a future SPC meeting.

10. Reports

10.1 SPC-19-02-01 Source Protection Program Update

M. Keller presented report SPC-19-02-01. J. Sepulis asked when a management framework will be in place for the Tier 3 models. M. Keller responded that a timeline has not been established. Lake Erie Region is considering requesting further provincial funding to continue developing the pilot studies. It will likely take months to years before a governance and management framework is in place.
